2. Compliance of this Order shall be made by **4th November, 2020** under intimation to this office. All the Officers In-charge (Hqrs)/DDOs are hereby directed to relieve the transferred officials **positively by 4th November, 2020(A/N)**. In case of any failure in relieving the transferred officials [except those transferred from the office(s) of the PR.CCIT, New Delhi], the transferred officials would stand relieved for new place of posting **w.e.f. 4th November, 2020(A/N)** and would not require any formal relieving order from any office and inevitably join their new place of posting on **5th November, 2020(F/N)**. However, in the case of those officials who are functioning as cashier in DDO charges, the compliance of this Order shall be made positively by **11th November, 2020(A/N)** and such officials [except those transferred from the office(s) of the PR.CCIT, New Delhi] would stand relieved for new place of posting **w.e.f. 11th November, 2020(A/N)** and would not require any

formal relieving order from any office and inevitably join their new place of posting on **12th November, 2020(F/N)**. In case the transferred officials are on leave with reference to aforementioned relieving date, they would invariably join their new place of posting on the next working day of the expiry of their sanctioned leave.


3. The DDOs will transfer the Service Book & LPC of the transferred officials to their new charge by 11th November, 2020 and the salary for the month of November 2020 will be drawn from the DDO of their new place of posting only.
4. The Office Superintendents under transfer to another building shall get their bio-metric attendance shifted to their new place of posting after joining it.
5. The Controlling Officers would ensure that the official(s) before being relieved submit his/her resume/self assessment to the concerned Reporting Officer.
